OFFICIAL PROCEEDINGS OF THE BOARD OF SUPERVISORS
APACHE COUNTY, ST. JOHNS, ARIZONA
February 20, 1973

Full Board met at 9:00 A.M. Minutes of February 5th were approved as published.

Representatives from the Town of Springerville were present to discuss some possible areas of cooperation between the town and county. Discussion will continue February 28th in joint county and city meeting.

School Superintendent met with the Board to canvas results of the special election held February 13th in Window Rock School District #8. The unofficial results were declared official with Allan Begay being elected for the term ending December 31, 1976 and Don Smith to the term ending December 31, 1973; also the capital outlay issue carried.

Application for original #11 liquor license, county #73-1, to Herbert Van Slyke in Alpine at the Tackle Shop, having been legally posted to be heard at this time, was considered. Petition bearing signatures from a number of Alpine residents opposing the granting of said license was presented. After considerable discussion, it was moved by Mr. Lee, seconded by Mr. McDonald, that a recommendation be postponed until March 5th.

Letter of resignation from Millard Scott as a member of the Planning and Zoning Commission was accepted and a recommendation for the appointment of Milton Thompson as a replacement was made and carried; term expiring November 1, 1973.

Concho Valley Unit 4A, a subdivision located in Sec. 16, T 12 N, R 26 E was given final approval under former subdivision regulations.

Paul Ellsworth with Little Colorado R.C. & D. discussed area projects including possible fire districts within the county.
