## OFFICIAL PROCEEDINGS OF THE APACHE COUNTY BOARD OF SUPERVISORS MEETING

October 4, 2022 St. Johns, Arizona

Present were Chairman Nelson Davis, and Supervisor Alton Joe Shepherd. Also present, was County Manager/Clerk of the Board Ryan Patterson and County Attorney Michael Whiting. Vice Chairman Joe Shirley, Jr. participated via the telephone.

Chairman Davis called to order the Board of Supervisors meeting at 8:30 a.m. in the Board of Supervisors' chambers, County Annex Building, 75 West Cleveland Street, St. Johns, Arizona, and welcomed all in attendance.

Kirsten Nielsen gave the invocation.

Matt Fish led the Pledge of Allegiance.

Chairman Davis called for the Health District items.

Kimberly Cole, Assistant Health Director, requested approval of Amendment #1 to the Flu and Pneumonia Vaccination Services Agreement between the Apache County Public Health Services District, Arizona Local Government Employee Benefit Trust (AZLGEBT) and Rural Arizona Health Group Trust (RAGHT), replacing Section II(1)(A), Section II (5), Exhibit A and B, effective October1, 2022. **Mr. Shepherd moved approval, seconded by Mr. Shirley.** Vote was unanimous.

Kimberly Cole, Assistant Health Director, requested approval of the Intergovernmental Agreement Contract No. CTR060578 for immunization services, effective July 1, 2022, to June 30, 2027. Ms. Cole stated this contract serves to increase immunization coverage levels of children 0-18 years of age and adults 19 and older, in the amount of \$50,000 and has been budgeted for in FY23. Mr. Shepherd moved approval, seconded by Mr. Shirley. Vote as unanimous.

Kimberly Cole, Assistant Health Director, requested approval of the Governor's Office of Highway Safety Grant, effective October 1, 2022, through September 30, 2023, in the amount of \$10,000. Ms. Cole stated this grant helps purchase car seats and provides education on proper installation, and has been budgeted for in FY23. Mr. Shepherd moved approval, seconded by Mr. Shirley.
